





- Your appointment is strictly for full time, adhoc & temporary in nature and shall be valid for the academic year 2023-24.
- This appointment shall not create any right or shall not allow you to claim any right on regular vacancies for the same post in future.
- 6. This offer of appointment is valid for seven calendar days from the issuance date. Within this valid period, you must report to the head of institute and join the duties, sign the 'Non-discloser Agreement' and submit the self-attested copies of all relevant testimonials, failing which your appointment is liable to be cancelled.
- 7. Your appointment is subjected to minimum number of students and the workload prescribed for the post from time to time. In case of reduction in work load, the institution shall have authority to terminate your service immediately and you shall not claim any right for service after the said period.
- 8. You shall undergo medical examination by the approved Medical practitioner or by the Civil Surgeon at the place of your duty and submit physical and mental fitness certificate to admin office within one month from the date of joining the duties.
- You are required to give the correct postal and mailing address as soon as you join the duties and any changes in the address given earlier should be communicated to the admin office e of the institute.
